Part A: Pupil premium strategy plan

Statement of intent

At Terrington St Clement we want *all* of our learners to be aspirational, to set themselves challenging goals and to work hard, growing in confidence and acquiring the skills needed to thrive. We aim to instil in our learners the belief that learning is limitless, that the world is full of opportunities waiting to be grasped and that through effort and perseverance everyone can succeed. This is equally, and perhaps more so, a firm goal for our most disadvantaged pupils. We are committed to ensuring that they are supported to overcome barriers to learning and provided with the opportunities needed to succeed.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

The key principles of our strategy plan are:

- To base our priorities on robust diagnostic assessment of the needs of individuals
- To share good practice within the school and draw on external expertise where necessary
- To provide high quality CPD to address and improve identified areas of need and ensure that all disadvantaged pupils are challenged
- To ensure all staff have high expectations of disadvantaged pupils

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Underdeveloped skills of emotional self-regulation, exacerbated by lockdowns and time out of school during the last 2 years; pastoral needs around coping with family circumstances
	Evidence: Increased pastoral support/referrals to EH or other Tier 2 services; observations of pupils in school & internal vulnerable pupil group monitoring; support in place for vulnerable families

2	Limited reading of a wide range of children's literature for some children in KS2 leading to underachievement in reading at KS2 for some PP.
	Evidence: Monitored reading choices and take up of school Reading Badge Challenge; achievement gap of -26% Reading at KS2 2023; previous progress in closing this gap reversed due to lost learning time; this had decreased so that PP were performing in line with Non-PP in Summer 2022 but increased again in 2023 although reflects +0.78 progress for PP which is was above Non PP.
3	Attainment gap at end of KS1, particularly in reading and maths – exacerbated by lost learning time.
	Evidence: More than 50% of Pupil Premium group in low attainment group end EYFS/KS1 (based on 2019 results); achievement gap of -31% Reading and Maths between PP and Non PP at KS1 in-house assessments Summer 2021. Gap closing in Summer 2022, achievement gap of -6% Reading, -20% Maths
4	Some limited access to reading books or homework support including remote learning access
	Evidence: Monitoring of remote learning engagement of pupils and greater challenges faced by some PP; increased support for parents/carers required to encourage engagement in any home tasks; parental feedback about challenges at home around home learning/access
5	Reading assessments, observations, and discussions with pupils indicate underdeveloped oral language skills and vocabulary gaps among many disadvantaged pupils particularly in KS1. These are evident from Reception through to KS2 and in general, are more prevalent among our disadvantaged pupils than their peers.
6	Writing outcomes for all, including PP following lost learning time. Stamina for writing has decreased and the gap between PP and Non-PP has increased.
	Evidence: ISDR Writing Attainment for all at KS1 and KS2 was significantly below national in both 2022 and 2023 (2023 - KS1 8 th Percentile, KS2 11 th); Gap between PP and Non PP at KS1 was -15% at KS2 it was -35%

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2022 to 2023 academic year.

The school is still feeling the impact of Covid learning disruption and now pressures on families due to the rapidly rising cost of living. This is impacting particularly on our less advantaged learners whose families frequently need support to source uniform and other basic necessities.

However, despite the challenges the school faced during this academic year, the impact of Pupil Premium outcomes in reading have continued to improve steadily with pupils overall exceeding national averages for the first time. For this cohort, pupil premium pupils also exceeded the progress made by their peers (+0.78 compared to -0.09).

In maths at KS2, pupil premium pupils are continuing to make greater progress year on year and are demonstrating progress beyond that of the last cohort pre-pandemic. The school transitioned from using an adapted Recovery Curriculum to the standard maths curriculum and has moved instead to focusing on trying to close the gaps for smaller cohorts. Collaborative work with the Cambridge Maths Hub supported the school to introduce STEM sentences to help embed key knowledge and plan effectively to ensure that both reasoning and problem solving is given equal priority.

Progress in writing was slower but the school has good evidence of progress from low starting points in all year groups. This is the area that was impacted the most and continues to be impacted through lost learning time and, for younger pupils, a shift in the type of activities happening at home. The school has worked closely with it's School Improvement Partner to structure writing lessons and formulate a clear approach to teaching writing. INSET was provided for all staff around this and this will be built on further this year.

The trialling and subsequent introduction of the ELS Phonics Scheme will support KS1 learners to become more confident in their decoding skills. This is being fully implemented this year.

For a small number of learners with underdeveloped social/coping skills, the impact of pupil premium funding has been to reduce behaviour incidents and the number of suspensions significantly.
